Description

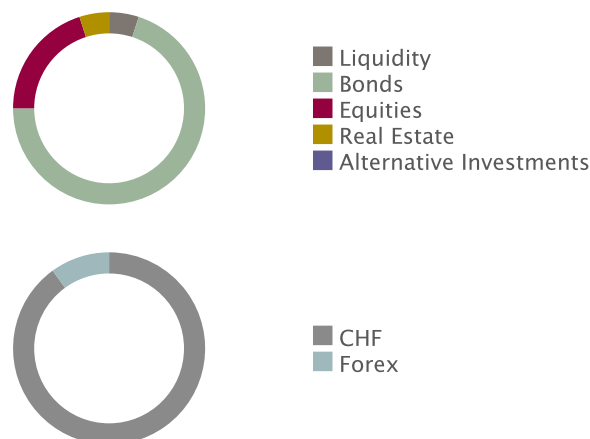

The strategy is reviewed each year based on clearly defined selection criteria, and adjusted as necessary. You benefit from low product costs and the portfolio can be delivered to your private assets upon withdrawal. The strategic equity content is 20%.

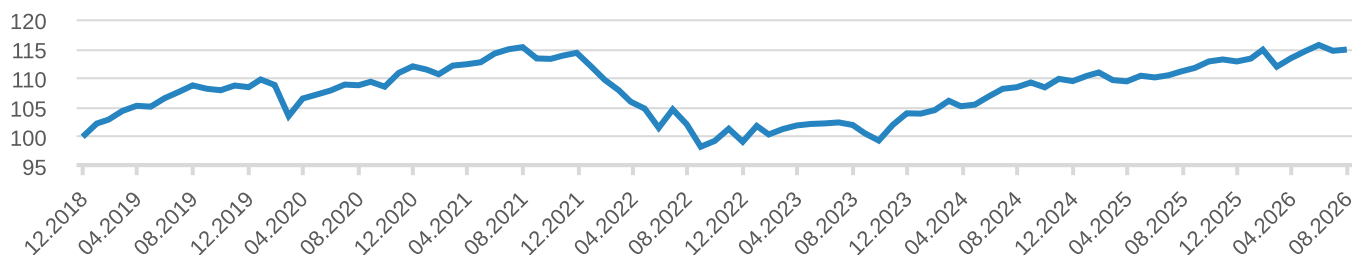

Methodology

The index funds are selected according to six predefined criteria (benchmark, performance, cost, deliverability, distribution approval and volume). The best product in the peer group is then chosen and weighted according to the strategic asset allocation in the "Selection Index 20" strategy. The dynamic strategy is quantitatively reviewed once a year and adjusted by the Board of Trustees.
