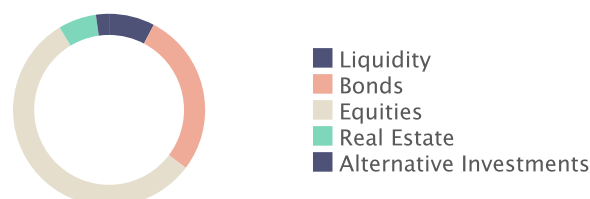

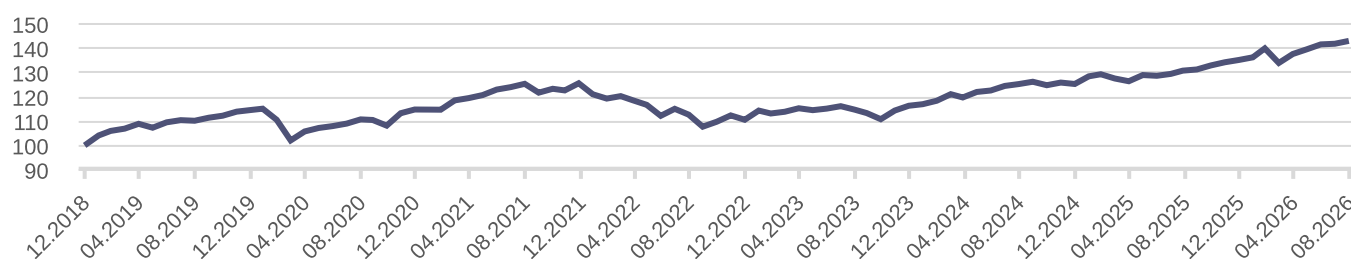

Methodology

The LPP strategy funds are compared over a three-year period based on six predefined criteria (performance, volatility, TER, Sharpe Ratio, maximum drawdown and maximum drawdown recovery). The three best pension products per peer group are then selected and weighted equally in the "Champ Max80" strategy. If no three products offer the required three-year track record, no more than three funds with the lowest costs (TER) are chosen. This quantitative selection process is conducted at least once a year (usually during fall) and if applicable, the strategy is automatically adjusted.
